PAYMENT OPTIONS

Students that wish to participate in a payment plan have two payment options:

If a student is not enrolled in a ECSI payment. The entire payment is due on the first day of class.

IMPORTANT NOTES REGARDING THE PAYMENT PLAN:

- Before you make your payment, please review your student statement to ensure all charges have been placed on your account and are correct (i.e., tuition amount, housing and other appropriate fees).
- You can view your current balance on the student portal. This will consist of all current charges minus the guaranteed and finalized financial aid.
- Regardless of the status of your financial aid, you are still required to make a payment on the current balance.
- Once you have opted for a specific payment plan you will not be able to change it until the plan is over or until the full amount is paid.
- The payment plan dates are final. Regardless of a statement/bill being received it is the student's responsibility to monitor their account on the student portal or reach out to the Business Office to confirm current amount due.
- A student can only sign up for a payment plan with ECSI during open enrollment. If the student misses the open enrollment for the current quarter, the entire current balance will be due in one payment.
